Appropriate signage and/or floor plan shall be placed near the elevators and/or stairs as well as midpoint of hallway. Subject to the approval of the Fremont Fire Marshal.

In accordance with Title 15 (Buildings and Construction) Chapter 15.55 (House Numbering) of the Fremont Municipal Code, this letter serves as the notice of the addressing action affecting your property. 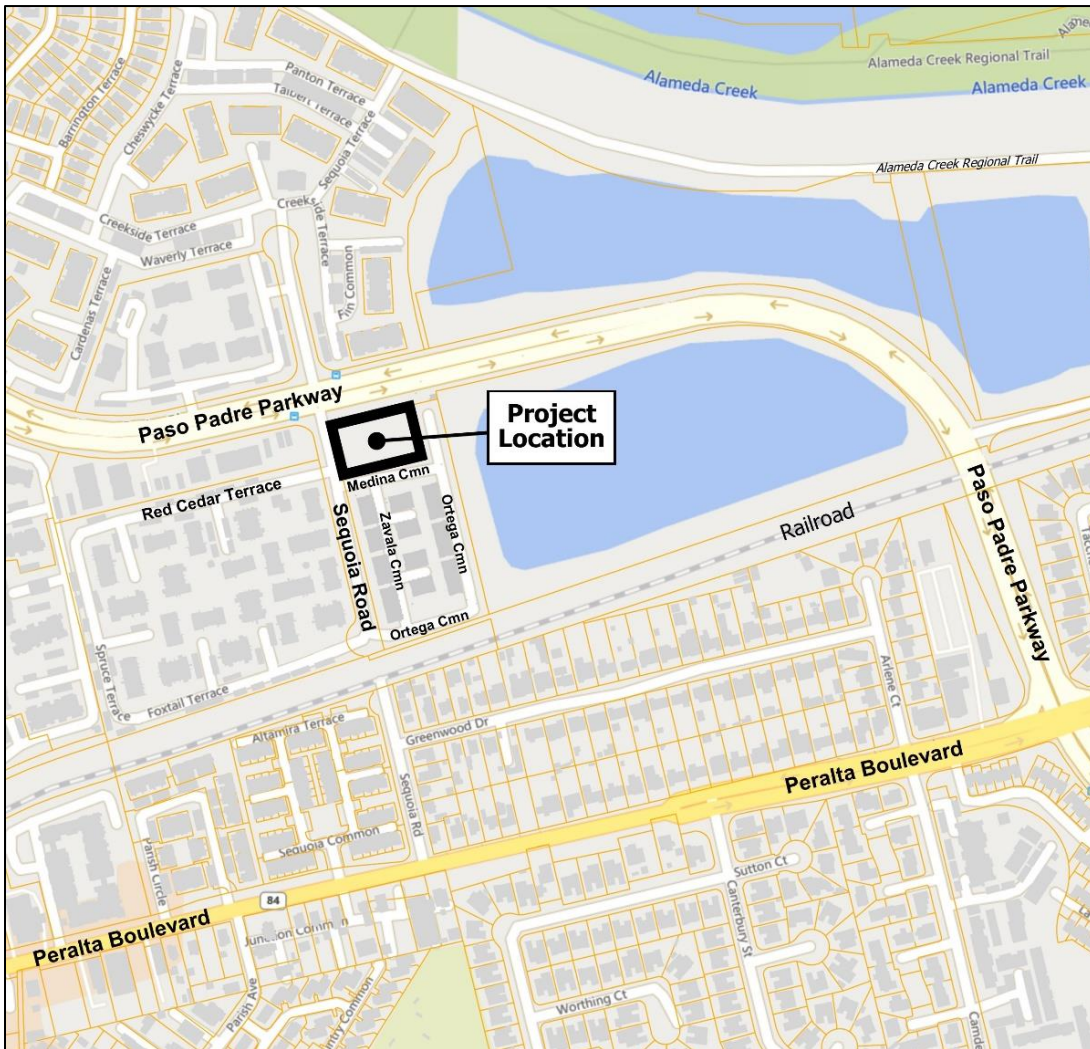
