Re: New Addressing for the Fremont Hub

As the Fremont Hub has gone through significant improvements and reconfiguration, it has been brought to the City of Fremont's attention that a significant number of addresses are out of sequence. There is great concern that in case of an emergency, personnel would not be able to quickly identify your tenant spaces. We have therefore devised a new addressing sequence for occupancies that are not located directly on Fremont Blvd, Mowry Ave, Argonaut Way or Walnut Ave. In addition, tenant spaces which are accessed only through the central corridor, will be addressed with the new street name "Fremont Hub Courtyard". The accompanying lists and maps outline all address changes and will serve as the official documents for this new configuration. As property manager, it is your responsibility to notify all of your tenants of the new addressing sequence and time line for implementation. All businesses are to be clearly marked with the new addresses and street signs posted within 60 calendar days.

The agencies listed below will be notified of your new addresses. Some agencies may not update their records until notified by the property owner. Therefore, it is your responsibility to contact the agencies directly to assure the address changes have occurred.
