




The City recognizes that the current addressing of the tenant spaces does not meet the City's required addressing standards but understands the need to limit disruption to existing tenants. Therefore, this new suite assignment is contingent upon compliance with the following **Conditions of Approval**:

- . Wayfinding signage and/or floor plans shall be posted on each floor to clearly indicate the unit numbers and flow direction. Appropriate signage and/or floor plan shall be placed near the elevators and/or stairs as well as where the street addresses change from 3340 Walnut Avenue to 39420 Liberty Street as identified in the accompanying addressing plan. Wayfinding signage and location of the sign is subject to the review and approval of the Fremont Fire Marshal.
- If any tenant space is vacated or subdivided/modified in the future, an addressing application is required to be submitted to the Fremont GIS Division to ensure suite addressing proceeds toward eventual full compliance with the City's addressing standards. Approval of suite addressing should be done prior to entering into a lease agreement and/or subdivision/modification of any tenant spaces.
