This letter is in response to your request regarding the validity and relocation of one (1) suite number address located at Assessor Parcel Number 525 085003100. I understand the request is needed to establish the use of the assigned address with the City of Fremont Building Division due to tenant improvement work which combine three suites (i.e. Suites 140, 160, 180) into one suite (i.e. Suite 160). The address you wish to use is 39510 Paseo Padre Pkwy Suite 160, and it may be used in the location indicated.
