To Whom It May Concern:

This letter is in response to your request regarding the validity of one address (i.e., 1118 Bonner Avenue) located at Assessor Parcel Number 507 040504200. I understand the request is needed to establish the use of the address as the parcel's property address with the Alameda County Assessor's Office. The address you wish to use is 1118 Bonner Avenue. Our records indicate that over time there had been two addresses associated with this property. The addresses are: 1118 Bonner Avenue and 1114 Bonner Avenue. Since the site is occupied by a single residential dwelling, only one address is needed. **With this addressing action, the address of 1118 Bonner Avenue is to be retained and is verified for use. The second address (1114 Bonner Avenue) is not required and is hereby rescinded.**

An inventory of the rescinded and verified addresses is shown on Table "A". The enclosed Addressing Plan shows the parcel and its verified address (i.e., 1118 Bonner Avenue). A copy of this letter will also be forwarded to the County Assessor's Office for their information.

You will need to check your address records and posted address to make sure they match the assigned address (i.e., 1118 Bonner Avenue). If they differ, they should be updated as soon as possible for the purpose of rapid identification of your property in the event of an emergency. In addition, please review and update any records that are registered with the City (such as for building permit and/or business tax purposes). By copy of this letter, we are notifying the below-listed agencies and utility companies as well as the County Assessor's Office. However, be aware that some agencies may not update their records until notified by the property owner. Therefore, it is your responsibility to make sure that the appropriate agencies or businesses acknowledge the correct address.
