This letter is in response to your request regarding the validity of 45188 Tom Blalock St Unit 309 located at Assessor Parcel Number 519 175902100. I understand the request is needed to establish the use of the assigned address with the Alameda County Assessor’s Office.

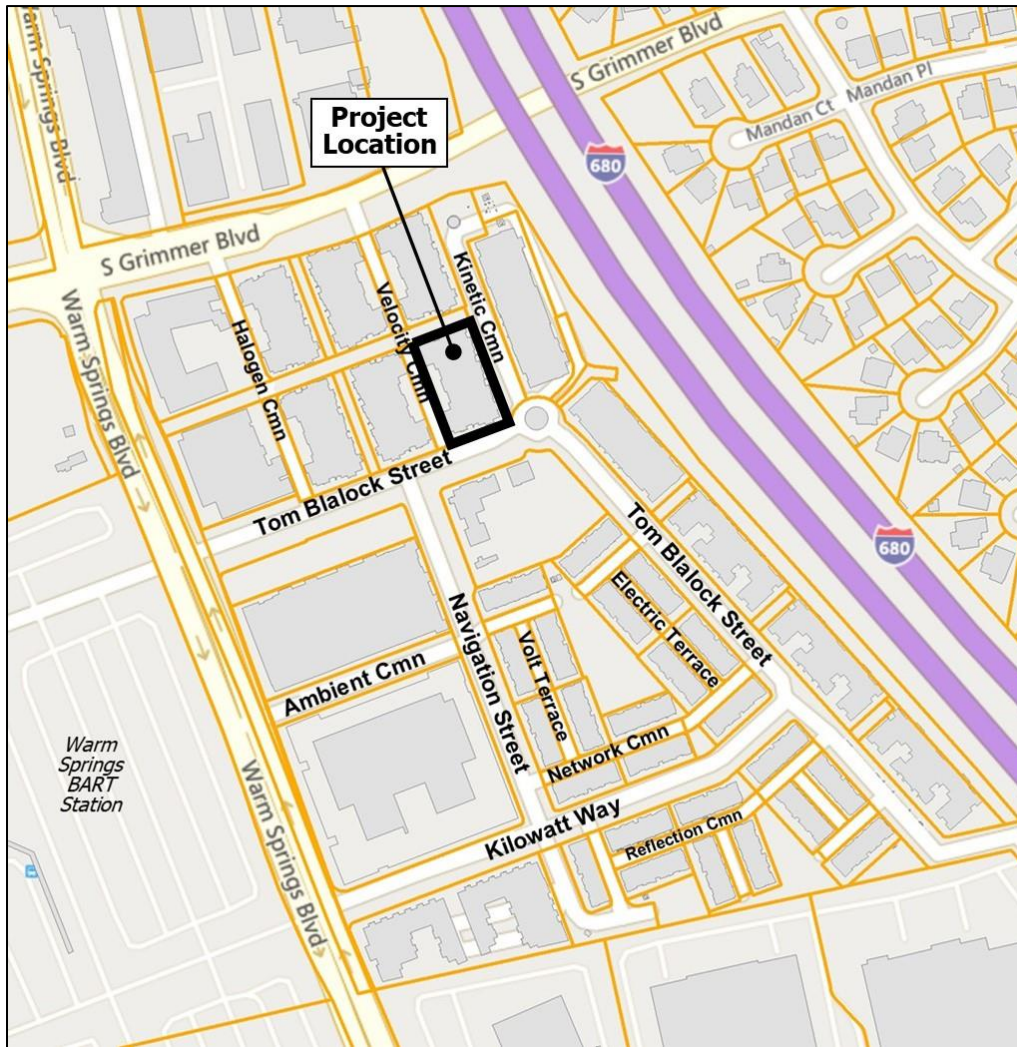
