To Whom It May Concern:

In response to your request for addresses needed for a new residential subdivision, a total of thirty-seven (37) new addresses have been assigned consisting of 33 single family lots addresses, three common area parcel addresses and one irrigation meter address. And as part of this addressing action, one existing address (i.e., 42785 Caldas Court) is verified for Lot 11 and one existing address (i.e., 42800 Caldas Ct) is rescinded. 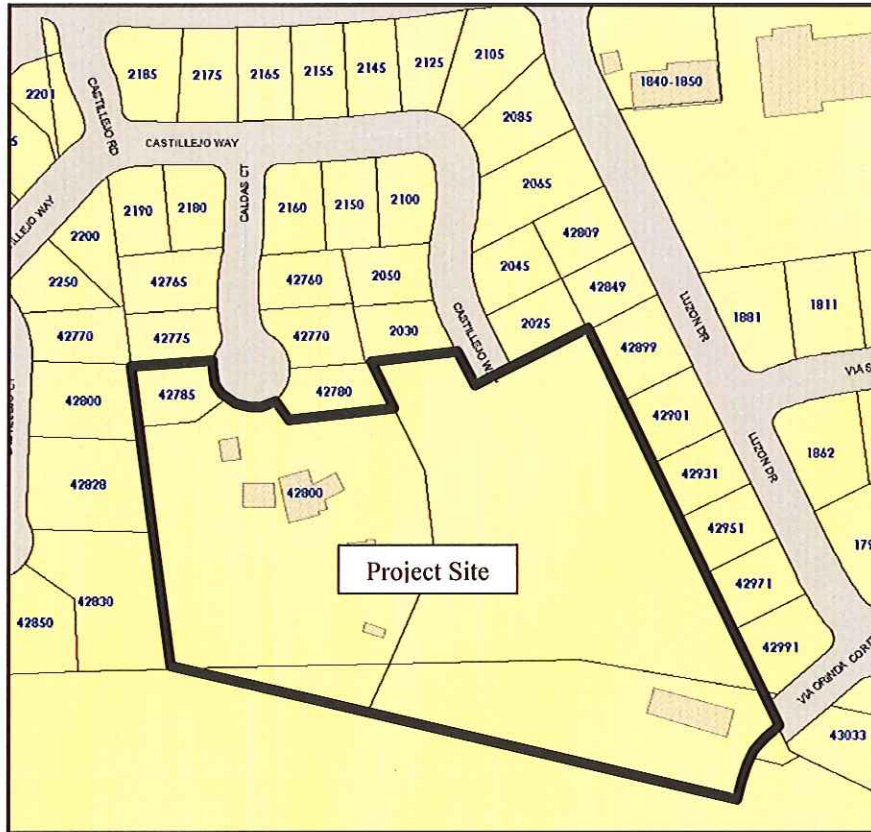
