

new address must be in use within ten (10) days of the receipt of this letter. 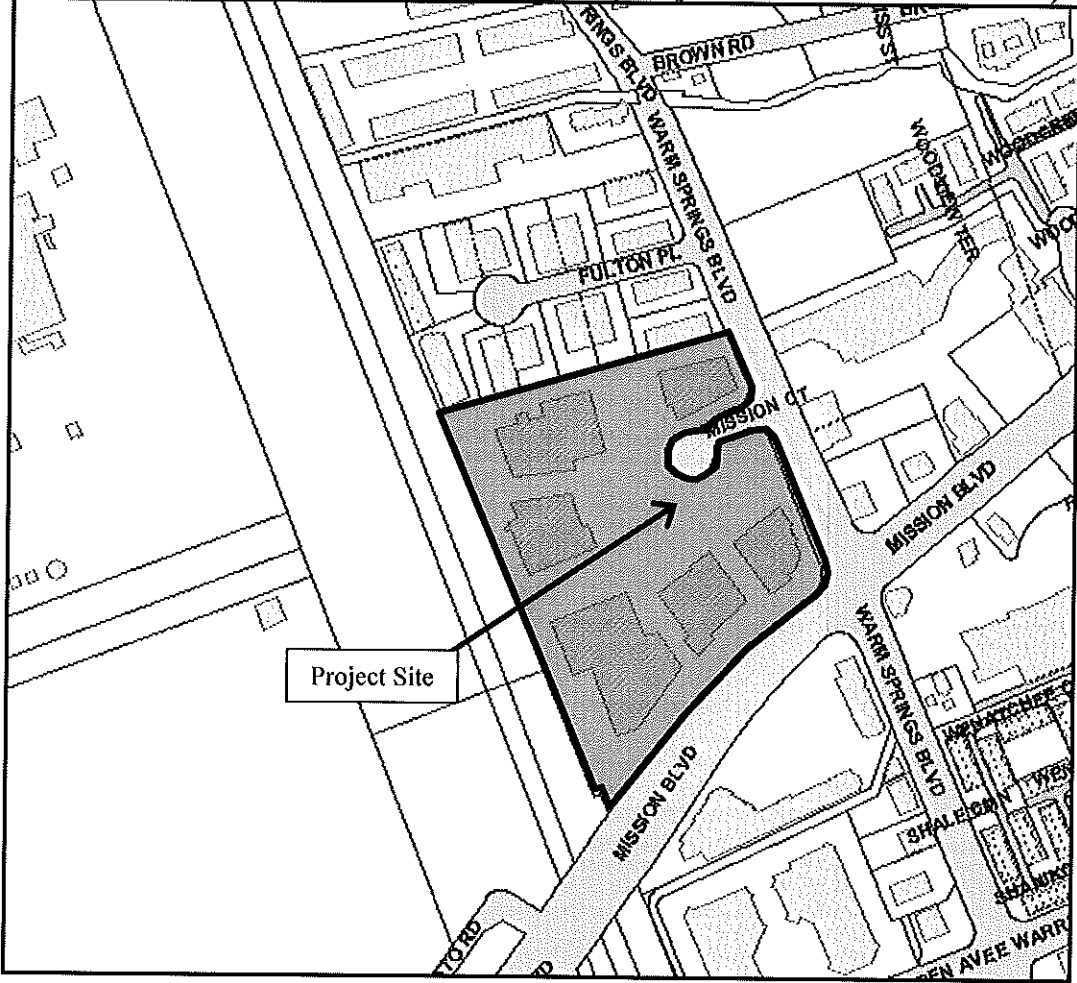
