To Whom It May Concern:

This letter is in response to your request regarding the verification and re-activation of two addresses located at Assessor Parcel Number 513 074900300. I understand the addresses are needed for two new tenant spaces being created at this parcel. The addresses you wish to use are 43539 and 43547 Mission Boulevard which had been assigned to the property in 2001 as part of the original addressing of the development. They are tenant space addresses and may be used in the location indicated on the enclosed Addressing Plan. See Table “A” for an inventory of the assigned addresses and enclosed Addressing Plan for their location.


