In accordance with Title VII (Building Regulations) Chapter 5 (House Numbering) of the Fremont Municipal Code, this letter serves as the notice of the addressing action affecting your property. For information on the size and location of address numbers on a building, please refer to Chapter 2 (Building Security) of the Title VII (Building Regulations).

Any occupants and property owner of this parcel should review and update their records that are registered with the City (such as for building permit and/or business tax purposes). Therefore, it is your responsibility to make sure that the appropriate agencies or businesses acknowledge the correct addresses.

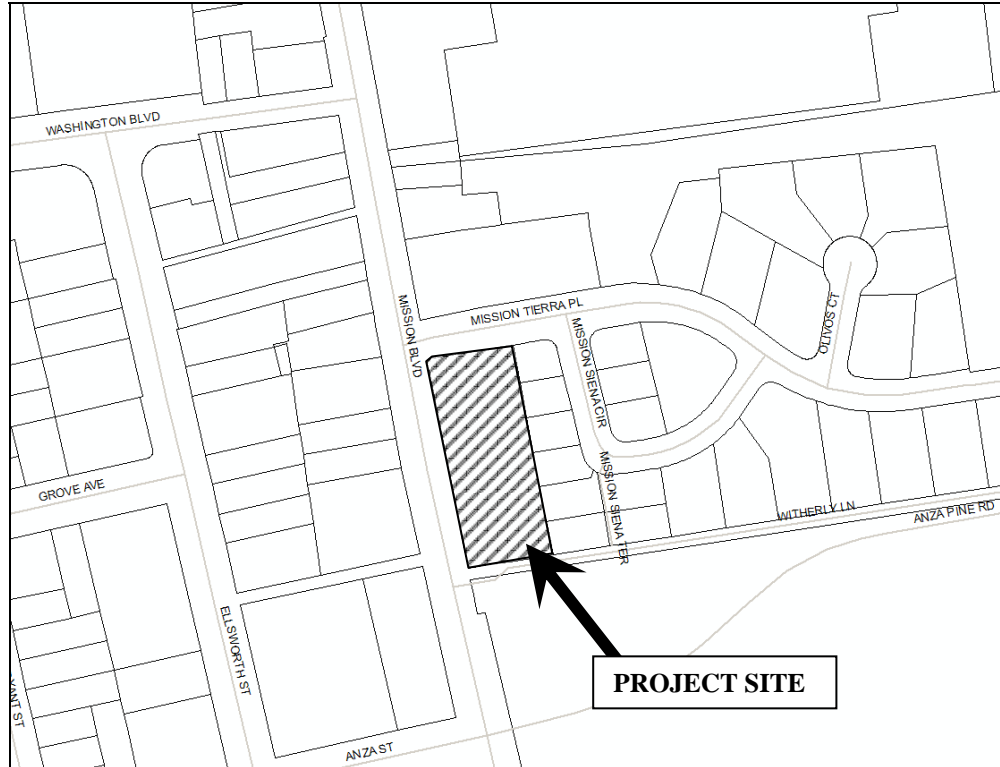
